

PUBLIC NOTICE

As provided by Chapter 197 Acts of 1974, notice is given that tangible personal property taxes assessed for the year 2021 are now delinquent and beginning April 1st, such taxes are drawing interest at 18 percent per year plus the proportionate cost of publishing this notice and delinquent cost. Unless the amounts set opposite each name below are paid prior to the 1st day of May, 2023, warrants will be issued thereon and the Tax Collector will apply to the Circuit Court for an order directing levy and seizures of the tangible personal property of the taxpayers for unpaid taxes, penalties and additional cost.
